To help you prepare for your tax preparation, there is a checklist of information to gather on the reverse side of this letter.

Our annual client information forms "clipboard intake forms" can be obtained in our office, OR you can complete them at your convenience by going to our website:

www.normastaxservice.com, after Jan 10. The online forms are fillable. You can save them to your device and upload them to our secure portal or print and fill them out manually to bring with your other documents. Please complete all forms that are applicable to you.

WHAT'S NEW IN THE TAX WORLD?

IPPIN's – These are not new, but now HIGHLY RECOMMENDED!!! Originally used for cases of compromised identities, but now used as a prevention. We recommend using the IRS.gov website to set up an IPPIN (Identity Protection Personal Identification Number) for additional security. Be sure to bring this with you or let us know when you drop off that you have an IPPIN

1099K – If you have VENMO, PAYPAL, SQUARE or other cash apps and have received payments of more than **\$20,000 or 200 transactions** you will receive a 1099K. You must provide us the form whether the payments are business or personal income.

Claiming Dependents – If more than one person can claim a dependent, we recommend having form 8832 signed by the custodial parent giving you permission to claim the dependent. Even in joint custody situations, one parent has the child one day more than the other. The form 8832 can alleviate misunderstandings regarding who is claiming that dependent.

Drop off's received until February 25th 2026 will receive \$35 discount

February 26th – March 15th will receive a \$25 discount
 You will still receive excellent service and communications via email, phone or portal.

- Business Mileage rate for 2025 was .70 cents per mile. The 2026 rate has not been released as of this letter.
- If you have 10 or more employees and contractors combined, you are now REQUIRED to electronically file W-2's and 1099's.
- If you want us to prepare and electronically file the 1099's for contractors and W-2's for employees, you must have your information to us no later than Jan 16, 2026.
